# DOL REPORT

- The department asked Bayliss & Ramey to voluntarily surrender their license in response to the company's letter stating they were no longer conducting business and were seeking bankruptcy protection. The Board stated they would not take any action until a notice of hearing was sent to the company for the next meeting.
- A report was provided to the Board on criminal charges being filed in magistrate court on various contractors.
- In a matter continued from the August 22, 2017 board meeting, Mr. Brady researched solar panel installation and found that only two states, California and Florida, have additional classifications for solar panel installation. No additional action was taken.

• The Board discussed a letter received by the department from Jacob A. Manning from the law firm of Dinsmore & Shohl, LLP regarding Greenbrier County Schools and their erroneous statement that the Board has determined that a Clerk-of-the-Works must have a West Virginia Contractor License. The Board discussed the School Building Authority's description provided by Mr. Manning and what a true clerk-of-the-works usually does and the consensus was that a that a true clerk-of-the-works does not need a contractor license; however, according to the duties and responsibilities of the clerk-of-the-works listed under the School Building Authority's Policy & Procedures, a contractor license will be required for a company or independent contractor hired by the school board to perform that work. The Board requested staff respond to the letter and inform the school board's attorney that the Contractor Licensing Board has not made a decision that all clerks-of-the-works must have a contractor license; however, the School Building Authority's description falls under that of a project manager and a license is required for that type of work.
