B. Timothy Cox DBA A+ Repairs – Bluefield, WV – WV048132 (Workers' Compensation Default list – Placed on list May 20, 2019 – Balance owed as of July 23, 2019 - \$668.00)

Ms. Farber informed the Board that Mr. Cox resolved his default with OIC prior to the meeting. Mr. Brady made a motion to remove A+ Repairs from the agenda. Mr. Smith seconded. Motion carried.

D. Thomas E. Ashley – Harperse Ferry/Lovettsville, VA – WV034030 (Allowed Donald Pine of Pine Properties to use his contractor license for a payment of \$1,000.00)

F. Lowes Home Centers, LLC – Mooresville, NC – WV014656 (3rd Offense of Hiring Unlicensed Subcontractors)

Mr. Solomon made a motion to issue a fine of \$1,000.00 and suspend license. After a discussion, Mr. Solomon made a motion to withdraw his original motion. Mr. Brady seconded. Motion carried to withdraw. Mr. Solomon made a new motion to issue a fine of \$1,000.00 and require the company to appear at the December 18, 2019 board meeting to submit a plan of correction or license will be suspended. Mr. Noel seconded. Motion carried.

- A report was provided to the Board on criminal charges being filed in magistrate court on various contractors. Mr. Sams advised the Board of an issue with Taylor County Magistrate Court allowing us to file criminal complaints, stating that we do not have jurisdiction, but all other counties have been cooperative.
- A copy of the Fiscal Year 2019 Financial Report was presented to the Board to review.
- Staff advised the Board of Pro-V meeting recruiting construction experts to participate in the development of a National Commercial General Contractor examination, scheduled for November 5 thru November 8.
- Staff updated the Board on member re-appointments and new appointments. Appointments were confirmed by the Legislature at a meeting this week.
