# MEETING CALLED TO ORDER

A quorum being present, Mr. Woodrum called the meeting to order at 10:00 a.m.

# APPROVAL OF MINUTES

Mr. Brown made a motion to approve the minutes. Mr. Gunnell seconded. Motion carried.

No one appeared for public comment.

#### **DISCIPLINARY HEARINGS**

The hearings are for licensees that failed to protest violation issued within ten (10) days from receipt of violation or protested violation and was denied, and the Board will hear evidence pertaining to fines and/or penalties on those violations.

**19-DISC-020** – **CMH Homes, Inc. DBA Clayton Homes #1028** – **WV01165.** Violated §42-CSR-19-10.A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard.

No one appeared on behalf of Clayton Homes #1028.

Ms. Rucker presented evidence and recommended a \$500.00 fine for failing to install a manufactured home in compliance with a state or federal standard.

Mr. Brown made a motion to reduce the fine to a Reprimand. No one seconded. Motion died.

Mr. Casto made a motion to **reduce the fine to \$250.00**. Mr. Belasco seconded. Motion carried 5-1 with Mr. Brown opposed. Mr. Gunnell recused himself.

Ms. Rucker presented evidence and recommended a **\$400.00** fine for §42-CSR-19-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard; and **\$750.00** fine for §42-CSR-19-10.A3 – Frostline considerations.

Mr. Brown made a motion to accept staff's recommendation. Mr. Casto seconded. Motion carried.
