#### MEETING CALLED TO ORDER

A quorum being present, Mr. Woodrum called the meeting to order at 10:01 a.m.

#### APPROVAL OF AGENDA

#### **APPROVAL OF MINUTES**

#### **DISCIPLINARY HEARINGS**

The hearings are for licensees that failed to protest violation issued within ten (10) days from receipt of violation or protested violation and was denied, and the Board will hear evidence pertaining to fines and/or penalties on those violations.

**21-DISC-001** – Cana MH, LLC – WV01272. Violated §42-CSR-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in accordance with state or federal standard.

Consumer Amanda Neu appeared on behalf of Amanda and Ronald Neu. No one appeared on behalf of Cana MH, LLC but a written response was submitted.

Mr. White presented evidence and recommended a \$500.00 fine for failing to install a manufactured home in accordance with state or federal standard with an order to correct within fifteen (15) days from receipt of order or license will be suspended

Mr. Solomon made a motion to amend staff recommendation to allowing the company thirty (30) days to make corrections or license will be suspended and company will be issued a fine in the amount of \$500.00. Mr. Shaw seconded. Motion carried.

**21-DISC-002** – CMH Homes, Inc. DBA Clayton Homes #1025 – WV01162. Violated §42-19-14.1(s) – The use of contract installation or repair services by a manufacturer, dealer or contractor/installer that is not properly licensed by this state.

Tom Young, General Manager, appeared on behalf of Clayton Homes #1025.

Mr. White presented evidence and recommended a \$250.00 fine for utilizing an unlicensed contractor.

Mr. Shaw made a motion to **amend staff recommendation to a Reprimand**. Mr. Solomon seconded. Motion carried. Mr. Gunnell recused himself.

**21-DISC-003 – Southern Energy Homes, Inc. DBA Giles – WV01030.** Violated §42-CSR-19-14.1(u) – Failure to fulfill any written or implied warranty obligations.

Mike Comparato appeared via telephone on behalf of Giles.

Mr. White presented evidence and recommended a \$500.00 fine for failing to fulfill warranty obligations.

Mr. Solomon made a motion to accept staff recommendation. Mr. Casto seconded. Motion carried. Mr. Gunnell recused himself.
