### MEETING CALLED TO ORDER

A quorum being present, Mr. Woodrum called the meeting to order at 10:00 a.m.

### APPROVAL OF AGENDA

Mr. Brown made a motion to remove 21-DISC-QTR062 and 21-DISC-QTR078 from the agenda, after coming into compliance, and approve the remainder of the agenda. Mr. Belasco seconded. Motion carried.

### APPROVAL OF MINUTES

Approval of the March 31, 2021 board meeting minutes.

Mr. Belasco made a motion to approve the minutes. Mr. Casto seconded. Motion carried. Mr. Brown abstained.

No one appeared for public comment.

### **DISCIPLINARY HEARINGS**

The hearings are for licensees that failed to protest violation issued within ten (10) days from receipt of violation or protested violation and was denied, and the Board will hear evidence pertaining to fines and/or penalties on those violations.

**21-DISC-004** – **CMH Manufacturing, Inc. DBA TRU-Halls** – **WV00113.** Violated §42-CSR-19-14.1(u) – Failure to fulfill any written or implied warranty obligations.

No one appeared on behalf of TRU-Halls.

Mr. White presented evidence and recommended a \$500.00 fine for failing to fulfill warranty obligations.

Mr. Solomon made a motion to accept staff recommendation. Mr. Casto seconded. Motion carried.

**21-DISC-005** – **CMH Homes, Inc. DBA Clayton Homes #1028** – **WV01165.** Violated §42-CSR-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in accordance with state or federal standard.

No one appeared on behalf of Clayton Homes #1028.

Mr. White presented evidence and recommended a \$500.00 fine for failing to install a manufactured home in accordance with state or federal standard with an order to correct within fifteen (15) days from receipt of order or license will be suspended.

Mr. Brown made a motion to accept staff recommendation. Mr. Belasco seconded. Motion carried.

**21-DISC-006** – CMH Homes, Inc. DBA Clayton Homes #1031 – WV01176. Violated §42-19-14.1(s) – The use of contract installation or repair services by a manufacturer, dealer or contractor/installer that is not properly licensed by this state.

No one appeared on behalf of Clayton Homes #1031.

Mr. White presented evidence and recommended a \$250.00 fine for utilizing an unlicensed contractor.

Mr. Brown made a motion to **amend staff recommendation to a Reprimand**. Mr. Belasco seconded. Motion carried.

**21-DISC-007** – Cavalier Home Builders, LLC DBA Clayton-Nashville – WV01179. Violated §42-CSR-19-14.1(u) – Failure to fulfill any written or implied warranty obligations.

No one appeared on behalf of Clayton-Nashville but a written response was submitted.

Mr. White presented evidence and recommended a \$500.00 fine for failing to fulfill warranty obligations.

Mr. Solomon made a motion to accept staff recommendation. Mr. Brown seconded. Motion carried.
