The West Virginia Board of Manufactured Housing Construction and Safety met September 28, 2023, at 1900 Kanawha Boulevard East, State Capitol Complex - Building 3, Room 200 - Charleston, West Virginia at 10:00 a.m.

MEETING CALLED TO ORDER

A quorum being present, Mr. Woodrum called the meeting to order at 10:00 a.m.

APPROVAL OF AGENDA

Mr. Brown made a motion to approve the agenda. Mr. Gunnell seconded. Motion carried.

APPROVAL OF MINUTES

Approval of the June 21, 2023, board meeting minutes.

Mr. Belasco made a motion to approve the minutes. Mr. Solomon seconded. Motion carried. Mr. Brown abstained.

PUBLIC COMMENT

No one appeared for public comment.

DISCIPLINARY HEARINGS

The hearings are for licensees that failed to protest violation issued within ten (10) days from receipt of violation or protested violation and was denied, and the Board will hear evidence pertaining to fines and/or penalties on those violations.

23-DISC-020 – Champion Home Builders, Inc. – WV01278. Violated §42-CSR-19-14.1.21 – Failing to fulfill any written or implied warranty.

Chris Stubblefield appeared on behalf of Champion Home Builders.

Mr. White presented evidence and recommended a \$250.00 fine for failing to fulfill warranty obligations.

Mr. Gunnell made a motion to reduce the staff recommendation to a Letter of Reprimand. Mr. Brown seconded. Motion carried.

23-DISC-021 – Cana MH, LLC DBA Cana Homes – WV01272/WV01331. Violated §42-CSR-19-10A.2(a)(i) and §42-CSR-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard.

No one appeared on behalf of Cana Homes.

Mr. White presented evidence and recommended a \$500.00 fine for failing to install a manufactured home in compliance with a state or federal standard and an order to correct within fifteen (15) days from receipt of final order. Failure to correct within the time specified will result in the suspension of License WV01331 until such time all corrections are completed.

Mr. Shaw made a motion to increase the staff recommendation of a \$500.00 fine to a \$1,000.00 fine and require company to appear before the Board at the next scheduled meeting or license will be revoked. Mr. Brown seconded. Motion carried.

23-DISC-022 – CMH Homes, Inc. DBA Oakwood Homes #721 – WV00962. Violated §42-CSR-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard; and §42-CSR-19-14.1.4 – Failure to establish and maintain records.

Travis Townsend appeared on behalf of Oakwood Homes #721.

Mr. White presented evidence and recommended a \$100.00 fine for failing to install a manufactured home in compliance with a state or federal standard and an order to correct within fifteen (15) days from receipt of final order. Failure to correct within the time specified will result in the suspension of License WV01331 until such time all corrections are completed; and a \$200.00 fine for failing to establish and maintain records.

Mr. Brown made a motion to change the staff's recommendation of a \$200.00 fine for failing to establish and maintain records to a Reprimand and to accept the remaining staff recommendation. Mr. Shaw seconded. Motion carried. Mr. Gunnell recused himself.

23-DISC-023 – CMH Homes, Inc. DBA Oakwood Homes #721 – WV00962. Violated §42-CSR-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state

or federal standard; §42-CSR-19-12.1 – Failure to transport a manufactured home in accordance with a state or federal standard; and §42-CSR-19-14.1.19 – Utilization of an unlicensed contractor.

Travis Townsend appeared on behalf of Oakwood Homes #721.

Mr. White presented evidence and recommended a \$200.00 fine for failing to install a manufactured home in compliance with a state or federal standard and an order to complete corrections within fifteen (15) days from receipt of final order. Failure to correct within the specified time-period will result in the suspension of License WV01279 until such time all corrections are completed; a Reprimand for failing to transport a manufactured home in accordance with a state or federal standard; and a \$250.00 fine for utilizing and unlicensed contractor.

Mr. Casto made a motion to accept the staff's recommendations. Mr. Shaw seconded. Motion carried. Mr. Gunnell recused himself.

23-DISC-024 – CMH Homes, Inc. DBA Clayton Homes #1024 – WV01161. Violated §42-CSR-19-14.1.4 - Failure to conduct site review and evaluations and establish and maintain records.

No one appeared on behalf of Clayton Homes #1024.

Mr. White presented evidence and recommended a \$500.00 fine for failing to conduct a site review and establish and maintain records.

Mr. Solomon made a motion to accept the staff's recommendation. Mr. Casto seconded. Motion carried. Mr. Gunnell recused himself.
